

Alter Everything Music Contest Rules

1. **Sponsor:** The Contest is hosted and sponsored by Alteryx, Inc. ("Alteryx") and is not sponsored, endorsed, or administered by, or otherwise associated with any third-party.
2. **The Contest:** The Alter Everything Music Contest is a music submission contest offering the opportunity for entrants to have their music featured on the Alter Everything podcast ("Contest"). Contest entries will be accepted beginning on **November 4, 2019 at 12:00:00AM Pacific Time through December 3, 2019 at 11:59:59PM Pacific Time** (the "Contest Period").
3. **Eligibility:** The Contest is open to individuals who, at the time of entry, (i) are 18 years of age or older and (ii) reside in one of the 50 United States, the District of Columbia, Australia, Canada (excluding the province of Quebec), Ireland, Netherlands, New Zealand, Norway, Singapore, and the United Kingdom. The Contest is null and void where prohibited. The Contest is subject to all applicable federal, state, and local laws and regulations. Employees of Alteryx and its subsidiaries, as well as the immediate family (spouse, parents, siblings, children and each of their respective spouses, regardless of where they reside) and household members of each such employee, whether related or not, are not eligible to participate in the Contest.
4. **Agreement:** By entering the Contest, the individual entrant ("You") accepts and agrees to be bound by these Alter Everything Podcast Music Contest Rules ("Rules"). You also agree to accept the decisions of Alteryx as final and binding with regards to the Contest.
5. **How to Enter:** No purchase necessary to enter or win. To enter the Contest, You must email a single audio recording of a song created by You (the "Submission") to podcast@alteryx.com in accordance with the requirements below. There is no limit on the number of entries per person.
 - a. The Submission must be a digital, audio file. No video submissions or submissions on physical media will be accepted. Only online entries will be eligible.
 - b. All Submissions must be in .mp3 format and must be at least 45 seconds and no more than 60 seconds. If a Submission is selected, the winner must be prepared to provide a recording in .wav format.
 - c. The Submission must be a musical composition that is only instrumental and may not contain any vocals or speech. The Submission may consist of electronic musical instruments.
 - d. The Submission must be "original" as defined by copyright law and created, written, performed, produced, owned, and controlled only by You. The Submission may not contain or feature any music that is created, written, performed, produced, owned, or controlled by someone other than You. The Submission may not have previously been used by You for another purpose, including to enter into another contest or promotion.
 - e. The Submission and Your email entry must not contain any infringing, harmful (including any malware or viruses), illegal, lewd, obscene, or otherwise objectionable content whatsoever. The Submission and Your email must not violate a third-party's rights, including intellectual property, publicity, or privacy rights.
 - f. The Submission must be received by the end of the Contest Period.
 - g. Any Submission or email entry that, in Alteryx's sole discretion, does not meet the above criteria will not be eligible to win.
 - h. Your email entry must include Your full legal name and identify Your U.S. state (or, District of Columbia, if applicable) or country of residence. You may only use Your personal email address and You must be the rightful account owner of such email address.
6. **Winner Selection:**
 - a. At least one (1) Submission will be selected as a winner ("Winning Submission(s)") to be featured on the Alter Everything podcast ("Prize").
 - b. Alteryx will judge all Submissions and judging will occur following the close of the Contest Period. Judging will be based on creativity, quality, and fitness for the Alteryx brand.
 - c. The Winning Submission(s) will be chosen December 16, 2019 and the individual(s) who submitted a Winning Submission ("Winner(s)") will be notified by email to the address associated with the Winning Submission(s). Winners will be required to sign and return, within seven (7) days of an initial notification attempt, a document that includes a declaration of eligibility, grant of a license for the Winning Submission, representation of ownership, and liability release (the "Release"). Failure to execute and deliver the Release to Alteryx may result in the forfeiture of the Prize.
 - d. Alteryx will not have any liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason.

- e. The Prize cannot be transferred or assigned to another person. No prize substitution or changes are allowed except at the discretion of Alteryx. The Prize cannot be substituted or redeemed for cash. In the event a Winner engages in behavior that is obnoxious or threatening, illegal, intended to threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or goodwill of Alteryx or any of Alteryx's services, products, trademarks, service marks, or logos, Alteryx reserves the right to revoke the Prize. Alteryx may also revoke the Prize upon becoming aware that the Winning Submission actually or potentially violates the requirements of Section 5(d) or 5(e) above.
7. **Representation/Warranty:** By entering the Contest, You represent and warrant that (i) You meet the eligibility requirements set forth in Section 3 above; (ii) Your Submission complies with all requirements and terms set forth in these Rules, and (iii) Your Submission and entry into this Contest does not violate any third party's intellectual property, privacy, or other proprietary rights. You agree to indemnify Alteryx and its subsidiaries, affiliates, representatives, agents, successors, assigns, employees, officers, and directors ("**Alteryx Parties**") from any third-party claim, suit, proceeding, or action, made against an Alteryx Party, and for any liability, loss, damage, costs, and expenses incurred by an Alteryx Party, arising out of an actual or alleged breach of the representations and warranties hereunder.
8. **License.** In consideration of Your Submission being reviewed and evaluated for this Contest, You grant Alteryx the irrevocable and worldwide right to use, reproduce, modify, display, distribute, perform, publish, transmit, and create derivative works of Your Submission, or any portion thereof, in any media now known or hereafter developed, and for any purpose, including marketing, advertising, and promotions of Alteryx, without additional compensation, notice, review, or consent. Alteryx will retain the rights granted in each Submission even if the Submission is not selected as a winner or is disqualified.
9. **Limitation of Liability:** By entering the Contest, You agree (a) to release and hold harmless the Alteryx Parties from any liability, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from Your participation in the Contest and/or acceptance and use of the Submission; (b) that any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred and in no event shall You be entitled to receive attorneys' fees or other legal costs or expenses; and (c) that You waive the right to claim any other damages whatsoever, including punitive, consequential, special, indirect, or direct damages. Alteryx Parties are not responsible for (i) technical failures of any kind, including the malfunction of any computer, cable, network, hardware, or software, or other equipment; (ii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iii) unauthorized human intervention in any part of the entry process or Contest; (iv) electronic or human error in the administration of the Contest or the processing of entries.
10. **Additional Terms & Conditions:** The Contest and these Rules, or any disputes arising therefrom, are governed by the laws of the State of California, United States, without regard to its conflict of law principles. Alteryx reserves the right in its sole discretion to modify the Contest Period or cancel the Contest at any time without prior notice or liability to You.
